ENHANCED COVID-19 SAFETY MEASURES

The County recognizes the critical leadership role it plays in preventing the spread of COVID-19. Accordingly, the County has

enacted a temporary mandatory face covering policy that requires County employees to wear facial coverings at all times while in an indoor, enclosed, or substantially enclosed County facility or worksite.

Visitors to the main administration office and other County facilities are also required to adhere to posted guidelines and restrictions, including:

EXPIRED: ALBERTA REMOVES LICENCE PLATE STICKERS

Submitted by Government of Alberta

Alberta's government first required registration expiry dates to be visible on Alberta licence plates in 1974. Due to advances in technology, stickers marking the month and year of registration, as well as stickers for fleet vehicles and permanent trailers, will no longer be issued in 2021.

In fall 2021, Alberta will transition to high-definition reflective licence plates. The reflective plates are more easily scanned by automated licence plate readers, which will assist law enforcement agencies using that technology to validate licence plate registration at roadside.

Reflective plates will be issued on a go-forward basis after the current stock of

printed licence plates runs out in the fall.

"Registry agents support this next step to modernizing the delivery of registry services. We applaud Minister Glubish for taking the initiative to make changes that will benefit Albertans and cut red tape." - Rikki McBride, chief executive officer, Association of Alberta Registry Agents

Alberta drivers and vehicle owners will still be responsible for renewing their registration on time, and will still require a valid certificate of vehicle registration. Albertans can sign up to receive an electronic renewal notice through a registry agent, the Alberta Motor Association, or MyAlberta eServices.

Quick facts

- There are more than 5.5 million vehicles registered in Alberta.

- The government currently spends about \$1.2 million per year to print, ship and store expiry stickers for licence plates.

- Stickers will still be required for farm vehicles and prorated commercial vehicles participating in the International Registration Plan.

- Vehicle registrations expire at midnight on the last day of an assigned month, based on surname or company name.

- One-year online vehicle registration renewals are available for passenger vehicles and motorcycles.

- Canadian jurisdictions that have eliminated the use of expiry stickers on licence plates are:

- Quebec (1992)
- Saskatchewan (2012)
- Northwest Territories (2014)
- Manitoba (2016)

WELCOME HOME JASPER PARKS CANADA FIREFIGHTERS



I was pleased and honoured to read the article by Joanne McQuarrie about our Jasper Parks Canada firefighters in the Jasper Fitzhugh paper on December 9, 2020. Our firefighters returned home in October after helping in the Lions

Head fire in Oregon from September 17 to October 2nd. There were 25 in total – a 20-pack unit crew, four task force leaders, one helicopter manager and a Parks Canada representative. The fire crew patrolled the perimeter of the areas on fire and were given a section of the area to patrol and extinguish hot spots. Hundreds of thousands of people, as well as 500,000 were evacuated at one point.

The Jasper crew included Brett Haug, fire technician, Beau Michaud, task force leader, along with Clayton Prail, Sean Buckle, Adam McNutt, Coulter Schmitz and Christine Brown.

All our firefighters deserve our appreciation and thanks.



RCMP EXECUTE SEARCH WARRANT

Submitted by St. Albert RCMP

This past November, the St. Albert Crime Reduction

Unit (CRU) assisted a neighbouring RCMP Detachment with an investigation relating to a Break & Enter. Two of the known suspects had past ties to property/fraud related crime in St. Albert.

On November 27, 2020 the St Albert CRU executed a search warrant for stolen property at a residence in Calahoo, Alta. The search warrant target suspects have been tied to over 15

break and enter investigations in Westlock, Parkland, and Sturgeon Counties as well as the City of Edmonton. Many of the break and enters were into rural properties. The investigation also revealed the suspects were attempting to sell some of the stolen items on Kijiji.

The search warrant recovered the following items:

- numerous stolen firearms
- tools
- power equipment
- all terrain vehicles with tampered and removed VINS
- a stolen truck.

As a result Clinton Galliford (40) of Sturgeon County, Gunther Schawarten (43) of Sturgeon County and Krystal Gregoire(32) of Sturgeon County have been charged with 36 Criminal Code offences including:

- Possession of Stolen Property
- Unlawful Possession of

Firearms

- Tampering with VINS
- Break and Enter
- CDSA offences

All three individuals are scheduled to appear in St. Albert Provincial Court on January 11, 2021.

Insp. Pam Robinson states, "Police Officers understand that crime has no boundaries and thanks to our Crime Reduction Strategy, we are identifying and targeting individuals who hurt our communities the most by driving stolen goods markets."

COVID-19 UPDATE FOR WHITECOURT

Submitted by Town of Whitecourt

Mandatory, province-wide restrictions announced by the Government of Alberta on December 8 have been put into effect to protect the health system and slow the spread of COVID-19.

These mandatory restrictions will in place at least until January 12, 2021. Health officials are monitoring the situation and will adjust measures if required. All Albertans, businesses, organizations and service providers must follow all new health measures.

Gathering Restrictions

Effective immediately, all indoor and outdoor social gatherings – public and private – are prohibited. This does not apply to service visits from caregivers, health or child care providers and co-parenting arrangements. Close contacts are limited to household members only. Individuals who live alone may have the same two non-household close contacts for the duration of this restriction.

Mandatory Mask Requirements

Effectively immediately, the Government of Alberta has implemented a requirement for masks in all indoor public places and workplaces across the province. While Whitecourt's Mandatory Face Covering Bylaw 1560 remains in effect, the Provincial restrictions supersede some requirements of the bylaw. Masks are mandatory in all:

- Indoor public places;
- Places of worship;
- Public Vehicles;
- Indoor workplaces and facilities outside the home except:
 - when working alone in an office or a safely distanced cubicle,

- rental accommodations used solely for the purposes of a private residence,
- farm operations.

The following exemptions apply throughout Alberta to a person attending an indoor public place if the person:

- is a child under two years of age;
- is unable to place, use or remove a face mask without assistance;
- is unable to wear a face mask due to a mental or physical concern or limitation;
- is consuming food or drink;
- is engaging in physical exercise;
- is providing or receiving care or assistance where a face mask would hinder that caregiving or assistance;
- is alone at a workstation and separated by at least 2 metres distance from all other persons;
- is the subject of a workplace hazard assessment in which it is determined that the person's safety will be at risk if the person wears a mask while working;
- is separated from every other person by a physical barrier that prevents droplet transmission; or
- is a person who needs to temporarily remove their face mask while in the public place for the purposes of:
 - receiving a service that requires the temporary removal of their face mask;
 - an emergency or medical purpose; or
 - establishing their identity.

Stronger Public Health Measures

A number of retail restrictions and mandatory closures will come into effect Sunday, December 13. For sector specific details on these stronger public health measures visit the Province's website. Until that date, all enhanced public health measures, which came into effect in Whitecourt on

December 2, must continue to be followed.

Financial support programs are available to help people, families and businesses facing hardship as a result of COVID-19. For more information, refer to Canada's COVID-19 economic response plan.

As announced by the Province, the Small and Medium Enterprise Relaunch Grant is available for businesses, co-ops, and non-profits impacted by COVID-19 to offset a portion of their costs.

Town of Whitecourt Operations

Whitecourt has a continuity plan in place to ensure essential services continue in our community uninterrupted, including road maintenance and utility services. The following facilities remain closed to public access, however there is no change in service level to the community:

- Whitecourt Fire Department,
- Public Works Shop,
- RCMP Detachment.

Due to the stronger public health measures, the following changes in service and operations will take effect Sunday, December 13, 2020:

- The following facilities will close to the public until at least January 12, 2021:
 - Allan & Jean Millar Centre - Annual and continuous monthly memberships will be placed on hold during this time (scheduled EFT payments will be suspended for January, 2021) and all January in-person fitness classes will be postponed, registered participants will be contacted with a new start date;
 - Scott Safety Centre;
 - Whitecourt Public Library; and,
 - Forest Interpretive Centre - except for Support Groups.
- Access to the Community Resource Centre will be limited.

Child care, out of school care, Family Support Program services, and the Whitecourt Food Bank will continue to operate.

Whitecourt Transit and Dial A Bus services will continue to operate with no changes to service.

The Twinkle Tour scheduled for December 19 and 20 is cancelled. The Town of Whitecourt will be compiling a map of local light displays for community members to reference for self-guided tours. Watch our social media platforms and website for information.

Outdoor recreation areas remain open for public use

Residents are encouraged to stay active, and are reminded that outdoor recreation spaces, including parks, public spaces, playgrounds, trails, and Toboggan Hill, remain open. Use at all mentioned facilities is permitted by members of the same household if physical distancing is maintained from other people at all times. Crews continue to prepare outdoor rinks, and the Town of Whitecourt will inform the community when they are available for public use.

Help prevent the spread
Community members are asked to continue to be vigilant in following preventative health practices, including physical distancing, cohorting, good hand hygiene, staying home when sick, and increased cleaning of surfaces. RCMP INVESTIGATE SUSPICIOUS VEHICLE AND MAKE AN ARREST

Spruce Grove, Alta. – On Dec. 5, 2020 at 3:08 a.m. Parkland RCMP responded to a report of a suspicious vehicle in the area of Westridge. The complainant advised that the vehicle had been cruising the neighbor-

hood for approximately 45 minutes.


