# PARKLAND RCMP LOCATE AND ARREST BREAK AND ENTER SUSPECTS

On Jan. 1, 2021 at 9:44 p.m. Parkland RCMP responded to a report of a break and enter into a residence in the area on Moonlight Bay, Township 531 and Range Road 40. The complainant reported that she was outside her residence and could hear what sounded like someone banging on her neighbor's cabin and she believed someone was breaking in. The complainant stated the suspects departed the location in a vehicle. She provided the direction of

travel, a detailed description of the vehicle and obtained a license plate.

As a result of the information provided by the complainant, the RCMP were able to locate the suspect vehicle, arrest the suspects and recover the stolen property.

The four suspect males, ages 21, 26, 29 and 30 from the Duffield area were all charged with break and enter with intent. Their first appearance is scheduled for Feb. 24, 2021. Their names will not be released at this time as their court documents are in the process of being sworn.

Thanks to the detailed information provided by the complaint, Parkland RCMP were able to apprehend the suspects and return the stolen property. If you observe a crime in process, safety is your first priority, however, providing as many details as possible is invaluable to a police investigation. Sergeant Major Kevin McGillivray commends the action taken by the complainant and stated "By working together, residents and police become active allies in the effort to keep our communities safe."

## January 19, 2021 **ALBERTA TO RUN OUT OF COVID-19 VACCINE SUPPLY**

#### Submitted by Government of Alberta

Premier Jason Kenney issued the following statement on vaccine supply in Alberta:

"Alberta Health Services has administered nearly 90,000 doses to eligible health-care workers and staff and residents in continuing care around the province to date. We continue to lead the large provinces in the pace of COVID-19 vaccination. This is positive news.

"I am also pleased to report that first dose vaccinations have wrapped up at all 357 long-term care and designated supported living facilities in the province.

"However, due to the unexpected supply disruption the federal government announced last week, Alberta will have no more vaccine doses available to administer as first doses by the end of today or early tomorrow.

"Accordingly, no more new first dose appointments will be accepted and some first dose appointments already booked will be rescheduled over the coming days to accommodate limited supply. Doses have been allocated to ensure second doses are available for committed appointments.

"As I have stated several times since our vaccine rollout started, our ability to get needed vaccine in the arms of Albertans is limited by the number of vaccine doses we have on hand. It is frustrating to see this happen while other countries, like the United States, the United Kingdom, and Israel have received significantly larger quantities of vaccines.

"I am deeply disappointed at the situation we are now facing. The news on January 15 that Pfizer shipments would be cut by 20 to 80 per cent over the coming weeks only adds to our frustration and means we have had to significantly slow down our vaccination plan.

"Alberta currently has the capacity to deliver 50,000 doses per week. In March, we expect to be able to administer about 200,000 doses per week. But we do not have the supply to match. Unfortunately, this means that the planned vaccination of First Nations and Métis individuals and seniors over age 75 has been put on hold.

"I want to assure Albertans that despite this setback, we remain in position to immediately ramp-up and get back to record vaccination numbers once sufficient doses are delivered. We remain undeterred in our efforts to get vaccines to those who need them most."

# YELLOWHEAD COUNTY COUNCIL HIGHLIGHTS

#### Submitted by Yellowhead County

January 12, 2021

Inoperative, Obsolete, and Expired Bylaws – Council passed Bylaw 1.21 which repeals inoperative, obsolete, and expired bylaws. For a list of these bylaws, please visit https://yellowheadcounty.civicweb.net and find the January 12 meeting agenda.

Evansburg Water and Sewer Local Improvement Fee – Council passed Bylaw 2.21 to impose the Local Improvement Levy for the 2021 taxation year. A local improvement fee can be imposed to fund a service or improvement applied to a particular area only. Yellowhead County has replaced the water and sewer infrastructure in a specific area of Evansburg at a cost of \$460,195.20. The county has covered half of the cost, and benefitting residents will have the option to either cover their portion of the cost entirely, or add it to their tax bill in equal installments over 25 years.

Nomination Bylaw – Council

passed Bylaw 3.21, rescinding Bylaw 10.16, to allow the use of credit and debit cards for the payment of any required nomination deposits only for the 2021 general election.

Agricultural Services Appeal Committee – Council appointed Robert Mitchell as Chair and Shelley Hay and Ryan Glylander as members at large to the Yellowhead County Agricultural Services Appeal Committee for 2021.

letters of support for designating the North Saskatchewan River under the Canadian Heritage Rivers System. This commemorative program is non-statutory; it does not add any further restrictions for development or use, but serves to celebrate and promote the natural, cultural, and recreational values of the river. Council approved sending a letter of support, which can be found online at https://yellowheadcounty.civicweb.net.

Erosion/Culvert Repairs – At the October 27, 2020 council meeting, council approved funding for emergent erosion/ culvert repairs at Site #5 (BF 81477) in the estimated amount of \$700,000. The project has since gone to tender and 5 tenders were received. Council awarded the tender for the replacement of BF 81477 to Prairie Erectors International Inc. in the amount of \$812,783.00 (lowest bid).

Evansburg Land Purchase Offer – Council has been approached by individuals seeking to purchase land in Evansburg. A municipality is restricted in how they may sell land at less than market value and the offer is below both the listed price and the assessed value. Council has directed administration to advise the interested party that the land price remains at the listed value of \$30,000.

Tax Recovery Auction Lot Sold – The county has received an offer from an individual to purchase a lot in Peers that was acquired by the county through the 2019 Tax Recovery Auction process. The vacant Peers lot is located at 4905 51st Street and is zoned Hamlet Residential. Council has agreed to sell the parcel of land for the reserved bid price of \$30,000 to the individual, pending all conditions of the sale are met.

The next regular Council Meeting is on January 26 and February 9 at 9:30 AM.

The next scheduled Governance and Priorities meeting will be held on January 19.

# PANDEMIC CHALLENGE INSPIRES CREATIVITY AND INNOVATION

Designing and building automated touchless hand sanitizers is the first of many projects planned for Grand Trunk High School's potential MakerSpace, where students learn a variety of skills in pursuit of personal and community projects: cosplay, electronics engineering, video game asset design, and computer programming.

GTHS teacher, Brett Watt, imagined two new and very relevant CTS projects - combining Design and Computer Science outcomes - for his students to design and build. Computer Science students will build the electronic circuits and then program them using Arduino coding that will operate the hand pump with no physical contact. Design Studies students will learn about Computer-Assisted Design using Google SketchUp including how to model various objects using the school's new array of 3D printers for the printing of the parts for the dispensers. While commercial stations can run up to \$250 per station, GTHS is spending about \$40 in parts. True innovation in action!

# **Keystone XL Pipeline: Premier Kenney**

"Doing so would kill jobs on both sides of the border, weaken the critically important Canada-U.S. relationship, and undermine U.S. national security by making the United States more dependent on OPEC oil imports in the future.

"In 2019, the United States imported 9.14 million barrels per day of petroleum, 3.7 million of which came from Canada. The rest comes from countries like Venezuela and Saudi Arabia, none of whom share the commitment of Canada and the United States to environmental stewardship, combatting climate change, or North American energy security.

"As President-elect Biden's green jobs plan acknowledges, Americans will consume millions of barrels of oil per day for years to come. It is in perfect keeping with his plan that the United States energy needs should be met by a country that takes the challenges of climate change seriously.

"The Keystone XL pipeline also represents tens of thousands of good-paying jobs that the American economy needs right now. That is why major American labour unions who supported President-elect Biden's campaign strongly back the project, as do First Nations who have signed partnership agreements, and all state governments along the pipeline route.

"As the Government of Canada has said, building Keystone XL is 'top of the agenda' with the incoming Biden administration. Prime Minister Trudeau raised the issue with President-elect Biden on their November 9, 2020, telephone meeting, agreeing 'to engage on key issues, including ... energy cooperation such as Keystone XL.' "We renew our call on the incoming administration to show respect for Canada as the United States' most important trading partner and strategic ally by keeping that commitment to engage, and to allow Canada to make the case for strengthening cooperation on energy, the environment, and the economy through this project.

"Should the incoming U.S. Administration abrogate the Keystone-XL permit, Alberta will work with TC Energy to use all legal avenues available to protect its interest in the project."

# EXPANDING FUNDING TO SUPPORT NEW BUSINESSES

Alberta's government is expanding its relaunch grant to ensure new businesses have access to the supports they need.

To better support Alberta's small business community through the ongoing public health crisis, the Alberta government is expanding the Small and Medium Enterprise Relaunch Grant to allow new businesses to apply. By expanding applications to businesses that started operating between March 1 and October 31, 2020, up 5,000 more Alberta businesses will be eligible for this funding.

New Alberta businesses impacted by public health orders will need to demonstrate a 30 per cent reduction of revenue using revenue figures from November or December 2020 compared with any prior month between March to October 2020. The payment is 15 per cent of their monthly revenue, for a maximum of \$15,000 in funding available for each business.

The Small and Medium Enterprise Relaunch Grant offers financial assistance to Alberta businesses, cooperatives and non-profit organizations with fewer than 500 employees that faced restrictions or closures from public health orders, and experienced a revenue loss of at least 30 per cent due to the COVID-19 pandemic.

Businesses can use the funding as they see fit to offset the costs they are facing as they relaunch their businesses. This includes the costs of implementing measures to prevent the spread of COVID-19, such as physical barriers, PPE and cleaning supplies, as well as rent, employee wages or replacing inventory. The funds can also be used to help businesses expand their online presence or e-commerce opportunities so that they can continue to serve customers.

The program launched at the end of June with a budget of

up to \$200 million. To ensure Alberta businesses have access to the supports they need, the budget was increased to \$500 million. More program details will be outlined on the program web page when finalized. Applications will be open until March 31, 2021, unless otherwise communicated.

Alberta's Recovery Plan is a bold, ambitious long-term strategy to build, diversify, and create tens of thousands of jobs now. By building schools, roads and other core infrastructure we are benefiting our communities. By diversifying our economy and attracting investment with Canada's most competitive tax environment, we are putting Alberta on a path for a generation of growth.

Quick facts

• Any new company that meets the 30 per cent threshold will be able to apply for the grant starting February 4, 2021.

- Small businesses that may be eligible under the new rules should wait until February 4 to apply, to avoid being deemed ineligible.

• Additional supports for businesses are available through the Federal Government

• Small and medium-sized businesses represent 99.8% of all job creators in Alberta, employing more than 500,000 Albertans.

#### Proposed Bylaw 2020-16: Land Use Bylaw Amendment Related to Use Classifications

Bylaw 2020-16 is a proposed amendment to Parkland County's Land Use Bylaw. The proposed amendment would reintroduce previously included uses to three of the County's Land Use Districts, listed as follows. In the Agricultural General (AGG) District: Boarding House, Cemetery, Community Recreation Services. In the Entwistle Urban Village (EUV) District: Home Day Care, Secondary Suite, Government Services. In the Rural Centre (RC) District: Educational Services, Government Services, Home Based Business Level 3. The reintroduction of these uses will align with the overall purpose of the respective districts and allow the County to support new and existing developments that align with their intent.

#### Hearing Procedure

This is a formal Public Hearing and Council is prepared to hear and receive formal submissions and presentations (verbal or written) from those who wish to speak to the proposed Bylaw. Written submissions or presentations may either be submitted in advance to Planning & Development by 4:00 p.m. on Jan 12, 2021, or submitted at the commencement of the Public Hearing on Jan 26, 2021.

Anyone wishing to make a verbal presentation to Council should notify Planning & Development Services in advance of the Public Hearing by 4:00 p.m., on Jan 12, 2021. Verbal presentations at the Public Hearing will be limited to a maximum of 10 minutes. Anyone wishing to make a verbal presentation who has not made prior arrangements may be allocated a time at the commencement of the Public Hearing. Council advises that this is your last opportunity to comment on the proposed Bylaw as Council is unable to receive further submissions after the Public Hearing is closed.

# CANADIAN CHARTER OF RIGHTS AND FREEDOMS WITH MESSAGES TO ELECTED OFFICIALS

Similar to people in com-

munities across Alberta, many residents of Drayton Valley are frustrated. On Sunday afternoon, Jan 17th many showed up at the offices of their elected officials to leave messages of concern. No gathering took place in the interest of public



safety, but the message was clear that every level of government is not doing enough to address the concerns of its citizens. People requested for all businesses to be opened to provide parity for all, for outdoor restrictions to be removed, reduction of salaries for politicians and bureaucracy alike, and for better more clear information to be provided with the daily Covid update from the province.

The information that is requested is briefly summarized as requesting the age ranges of those deceased, how many have co-morbidities, a breakdown where the case numbers are located (in their own homes vs public care facilities), what the stats need to look like that would either increase or decrease restrictions, (goal-posts) why the input of David Redman has not been sought out or ignored, and what the province will do to protect individual rights if businesses start to demand proof of vaccinations so that they can better understand what we're collectively facing.

The provincial and federal governments have had nearly 10 months to plan to address the issues, and yet they seem to still be at the starting point, providing inconsistent messaging with a lack of supporting detail as to what information was utilized in their decision making process. These Albertans and Canadians deserve better, as do all citizens.

Easing of restrictions for outdoor gatherings, personal services and funeral attendance will take effect Jan. 18.

While indoor gatherings remain prohibited, up to 10

people will be allowed at outdoor social gatherings. Personal and wellness services will be allowed to open by appointment only. Funeral ceremony attendance will be increased to 20 people, with mandatory masking and two metre physical distancing. Funeral receptions are still not allowed. All Albertans, businesses, organizations and service providers must continue to follow all other existing health measures.

"This limited easing of restrictions is possible thanks to the efforts of Albertans over the past few weeks. But, we need to be careful that we don't reduce too early

and risk the steady improvements we've made since November. We want to ensure the safety of Albertans, while balancing the uncertainty faced by Alberta businesses and service providers. We will be continually evaluating the public health data to make adjustments where possible." - Jason Kenney, Premier

"Albertans have done a good job of staying the course and abiding by public health measures, but we are still seeing high hospitalizations and case numbers, and this continues to put a serious strain on our healthcare system. How much further we can ease restrictions depends on our collective efforts over the coming days and weeks to limit the spread of the virus." - Tyler Shandro, Minister of Health

"Although we've seen a decline in transmission, our health-care system is still at risk. We must remain diligent in our efforts to bring our numbers down even further. By easing some measures like outdoor gathering limits, we hope to support Albertans' mental health, while still following other restrictions that are helping us reduce case numbers." - Dr. Deena Hinshaw, chief medical officer of health

Provincial and regional trends will continue to be monitored and assessed over the coming weeks to determine if further easing of restrictions may be considered.
