### CHARGES LAID AGAINST GRACE LIFE CHURCH

**Submitted by Parkland RCMP**

On February 8, the RCMP swore a charge against James Coates, the Pastor of the Grace Life Church, in contravention of Section 73(1) of the Public Health Act, for being over capacity and failing to adhere to physical distancing requirements. Coates has been served an Undertaking with

conditions and is to attend in Provincial Court in Stony Plain on March 31, 2021.

The RCMP can confirm that in December a violation ticket was issued to the Pastor, and on Feb. 7 the Pastor was arrested and released with a court appearance date.

Since early December the RCMP have been working with AHS in an ongoing investigation into the activ-

ities surrounding the non compliance of the church. AHS has maintained a position of being the lead investigating agency. On Feb. 7, the RCMP, along with the Public Health Inspector with AHS, attended the church and determined that the facility was over double the current restricted capacity level.

wood Office, and 8:00 AM to 4:30 PM, Monday to Friday at the Edson Office.

Please note that you will be asked to complete a questionnaire and sign an authorization form to e-file your tax return by the volunteers. No records or documents will be kept by the volunteers.

following the end of the service. “There are many different discussions and considerations at play in relation to the Grace Life Church and their non compliance” says

Inspector Mike Lokken, Detachment Commander of Parkland RCMP. “We have ensured that the church is well aware of the conditions that they need to follow and they have been afforded

repeated opportunities to comply. In collaboration with AHS, we have now followed up with escalated enforcement.”

- 2 person income \$45,000 or less
- 3 person income \$47,500 or less
- 4 person income \$50,000 or less
- 5 person income \$52,500 or less

# GOVERNMENT OF CANADA ADDRESSES CERB REPAYMENTS FOR SELF-EMPLOYED INDIVIDUALS AND ANNOUNCES INTEREST RELIEF ON 2020 INCOME TAX DEBT DUE TO COVID-19 RELATED INCOME SUPPORT

Feb. 9, 2021 - Since the beginning of the COVID-19 pandemic, the Government of Canada has provided urgently-needed income support to millions of Canadians, which has helped them put food on the table and keep a roof over their heads during this crisis. The federal government is committed to continuing to support Canadians throughout this crisis.

Today, the Government of Canada announced that self-employed individuals who applied for the Canada Emergency Response Benefit (CERB) and would have qualified based on their

gross income will not be required to repay the benefit, provided they also met all other eligibility requirements. The same approach will apply whether the individual applied through the Canada Revenue Agency or Service Canada.

This means that, self-employed individuals whose net self-employment income was less than \$5,000 and who applied for the CERB will not be required to repay the CERB, as long as their gross self-employment income was at least \$5,000 and they met all other eligibility criteria.

Some self-employed individuals whose net self-employment income was less than \$5,000 may have al-

ready voluntarily repaid the CERB. The CRA and Service Canada will return any repaid amounts to these individuals. Additional details will be available in the coming weeks.

In addition, today, the Honourable Diane Lebovitch, Minister of National Revenue, announced that the Government of Canada will provide targeted interest relief to Canadians who received COVID-related income support benefits. Once individuals have filed their 2020 income tax and benefit return, they will not be required to pay interest on any outstanding income tax debt for the 2020 tax year until April 30, 2022.

This will give Canadians

more time and flexibility to pay if they have an amount owing.

To qualify for targeted interest relief, individuals must have had a total taxable income of \$75,000 or less in 2020 and have received income support in 2020 through one or more of the following COVID-19 measures:

- the Canada Emergency Response Benefit (CERB);
- the Canada Emergency Student Benefit (CESB);
- the Canada Recovery Benefit (CRB);
- the Canada Recovery Caregiving Benefit (CRCB);
- the Canada Recovery Sickness Benefit (CRSB);

## HOW TO PLAN A WINTER WEDDING

Weddings take place throughout the year, but some months have traditionally proven more popular times of year for happy couples to tie the knot.

Summer was long known as the most popular season for weddings, but that trend has shifted in recent years. According to the 2020 WeddingWire Newlywed Report, 36 percent of couples get married in the fall, making autumn the most popular time to say "I do."

Though October and September are the two most popular months to marry, budget-conscious couples may want to consider getting married in winter. December, January and February are the least popular wedding months, but the experts at WeddingWire note that getting married during the slow season has its benefits. Vendors, including wedding planners and venues, may offer

their services and facilities at discounted prices in winter to account for the slow season. And guests might be thankful to have a fun event to look forward to during a time of year when social schedules tend to be less busy.

Many wedding components will stay the same regardless of when couples walk down the aisle. However, couples may need to take a few things into consideration as they begin planning winter weddings.

- Avoid holiday weekends. Just because social schedules are not always so busy in winter that doesn't mean couples can pick any winter weekend to tie the knot. The holiday season, which begins on Thanksgiving weekend in late November and lasts until New Year's Day, is a hectic time of year for many people. Avoid holiday weekends like Thanksgiving and the weekends before or

after Christmas and New Year's Eve/New Year's Day. These weekends already are busy travel times, so couples might not be able to get guest-friendly rates on hotel rooms, and some guests may already have plans to visit family. In addition to the December holidays, avoid the first weekend in February. That's Super Bowl weekend, and many people may be reluctant to travel on the day of the big game.

- Research local weather. It's impossible to predict the weather, but savvy couples can research local weather in the town or city where they're getting married to determine when is the most travel-friendly month to host their weddings. Some regions get heavy snowfall in January, while others may be more susceptible to late winter snowstorms. Couples with a lot of out-of-town guests should choose a winter

weekend where snowfall is unlikely so guests don't have to endure travel delays on their way to and from the wedding.

- Purchase wedding insurance. Wedding insurance is a wise investment for every couple, but it can be especially valuable for couples tying the knot in winter. Each policy is different, but wedding insurance policies should protect couples' investments if storms force local officials to declare a state of emergency that prohibits travel. Make sure the policy covers both cancellations and postponements.

Winter weddings can help couples save money. Planning such affairs may require paying attention to details that would not garner much consideration during other times of year.

## HOW TO AVOID WEDDING RECEPTION SEATING MISTAKES

Weddings are great opportunities for people to gather and celebrate the melding of two families into one. Weddings are a melting pot, and while the ultimate goal is for all guests invited to mingle and have a good time, preexisting relationships may cause some wedding-day interactions to be strained. However, with careful planning and some best behavior on the parts of all involved, getting hitched can go off without a hitch. It's possible for guests who may have tumultuous pasts to keep the peace, but this also can be ensured through careful seating arrangements. This is just one factor couples need to consider when deciding where guests will sit and dine at receptions. It's important to avoid some common mistakes.

Mistake #1: Not having a seating

plan. Let guests sit where they want and chaos may ensue. People may think they're entitled to certain seats, may hop into seats vacated by someone getting up to use the restroom or any number of other scenarios. Seating arrangements also ensure everyone is accounted for across the room.

Mistake #2: Seating families separately. Unless there are rifts between certain family members, it's best to seat parents and children at the same tables.

Mistake #3: Trying to force new friendships. Avoid trying to figure out who will get along by creating a potpourri table. A cousin in a band will not necessarily want to sit next to your coworker who plays guitar simply because they have a shared love of music. A wedding is not the time to try

to create new friendships. If it's meant to be, they'll connect in a more organic way.

Mistake #4: The dreaded kids' table. Young children can probably get away with sitting at a dedicated kids' table, although it may mean their parents have to interrupt their experiences by checking on their kids throughout the night. A bigger faux pas is to sit teenagers or twentysomethings at the kids table even if they seem like youngsters to you. Set a strict cut-off age for a children's table.

Mistake #5: Being too strict in seating. It's one thing to direct couples or singletons to specific tables, quite another to assign specific seats. Do not dictate exactly where at the table a guest should sit. Some people arrive early, others late, and it is up to them to work out how to arrange

themselves at the table.

Mistake #6: Failing to get family feedback. Always check with your parents and future in-laws as resources about how to seat certain guests. They'll likely know who will make the best table-mates, especially if couples are not familiar with everyone on the guest list.

Mistake #7: Not being aware of disabilities or needs. Be conscious of guests' needs. An elderly relative may not be comfortable in front of the DJ table. A person in a wheelchair may need easy access to and from the reception room. It's important to be mindful of these special needs.

A seating plan for wedding receptions is an important consideration so that every guest can feel comfortable.

# Government of Canada Addresses CERB Repayments for Self-Employed Individuals and Announces Interest Relief on 2020 Income Tax Debt Due to COVID-19 Related Income Support

- Employment Insurance benefits; or
  - similar provincial emergency benefits.
- The Canada Revenue Agency (CRA) will automat-

ically apply the interest relief measure for individuals who meet these criteria. Additionally, any CRA-administered credits and benefits normally paid monthly or quarterly, such as the Canada Child Benefit and

the goods and services tax/harmonized sales tax credit will not be applied to reduce individuals' tax debt owing for the 2020 tax year. Canadians are strongly encouraged to file their tax returns by the filing deadline

to ensure that their benefit payments continue without interruption.

The Government of Canada recognizes that many Canadians continue to face serious financial impacts as a result of the ongoing pandemic. The interest relief measure announced today will provide an estimated 4.5 million low- and middle-income Canadians with the flexibility required to feel confident about accessing the COVID-19 income support without facing additional stress at tax time.

**Quick Facts**

- All individuals are encouraged to file their income tax returns.
- Any amounts owing are determined based on an individual's personal circumstances and the credits and benefits they may receive.

- Like Employment Insurance (EI) benefits, the COVID-19 emergency and recovery benefits, including similar provincial benefits, are taxable. Although 10% of the benefit amount for the three Canada Recovery Benefits (CRB, CRCB, and CRSB) is withheld at source, many other emergency benefits, including the CERB and the CESB did not withhold tax at source. Today's announcement will give those Canadians who owe any taxes as a result of accessing these benefits more time and flexibility to pay those amounts.

- The CRA has not extended the tax filing deadline. Canadians should complete and submit their tax returns by April 30, 2021, the filing due date for most individuals. Canadians are strongly encouraged to file their tax returns to ensure that their benefit payments continue uninterrupted.

# RURAL DUGOUTS FOR RURAL PROPERTIES: MORE THAN JUST A HOLE IN THE GROUND

Over the last 100 years more than 250,000 dugouts have been constructed on rural properties across the prairies. Four counties are partnering to host a two-part Zoom webinar with information about ways to care for these important sources of water on farms and other rural properties.

During his presentation, Shawn Elgert, Agricultural Water Engineer with Alberta Agriculture and Forestry, will cover a wide range of topics including planning considerations, design, construction, operation and protection, water quality issues and treatment solutions, and dugouts for stocking fish. The sessions also include time for ques-

tions. These water reservoirs serve many uses: for livestock watering, outdoor and greenhouse irrigation, recreation, and a source of water for pesticide application and fire fighting. Elgert says dugouts are miniature ecosystems and require proper design and maintenance to provide suitable water quality and quantity for the intended uses. Because runoff surface water is usually the source of water for dugouts, the water quality can be poor. However, dugout water quality can be managed, improved, and treated to meet most farm needs. Good dugout management starts with the dugout watershed and extends right through to the final use. As dugouts age they fill with sediment and their water storage capacity becomes smaller. The life span of a dugout can be

extended significantly through effective management.


