GRACELIFE CHURCH UPDATE

Update 6

Last week, on March 4, the legal counsel for GraceLife Church was served with a Summons to attend Stony Plain Provincial Court on May 5, 2021. GraceLife Church was charged as an entity for exceeding the 15%

allowable capacity for the services held on Feb. 21 and Feb 28., 2021, contrary to section 73(1) of the Public Health Act.

The Parkland RCMP supported the AHS investigation at GraceLife Church this past Sunday. The Church was non compliant with the Public Health Order in that it was over the

allowed capacity. The RCMP members were present for public safety and to support AHS, and did not go inside the church.

Investigation continues into the church by AHS and supported by the Parkland RCMP. These charges are now before the court and further comments will not be available.

official Advance Payments Program open date on April 1, producers can complete their online application today and explore new account features including a designated FarmCash account manager and an online account dashboard. These features provide a cash advance experience tailored to the unique needs of agriculture producers.

Western Canadian producers of over 50 agriculture commodities including crops, livestock and honey,

can apply for up to \$1 million with the first \$100,000 interest-free and the remaining balance at a competitive interest rate of TD prime minus 0.75 per cent.

“The uptake of FarmCash as a business management tool continues to grow and we are excited to open up the enhanced program to producers in additional provinces,” says Todd Hames, Alberta Wheat Commission chair.



DRUG TRAFFICKING INVESTIGATION RESULTS IN AN ARREST

Submitted by Parkland RCMP

Drayton Valley, Alta. – The Parkland RCMP Drug Unit initiated an investigation of a suspect believed to be trafficking prohibited substances. With assistance from the Drayton Valley RCMP GIS section, the Parkland RCMP Drug Unit gathered intelligence and obtained search warrants. On Feb. 18, 2021, the Parkland RCMP Drug Unit, with the assistance of the Parkland RCMP Crime Reduction Unit executed two search warrants in Drayton Valley after concluding their investigation. Drayton Valley RCMP assisted with the arrest and took custody of the suspect.

Tyson Niles (33) of Stony Plain, Alta. was arrested and charged with:

- Possession for the purpose of trafficking fentanyl
- Possession for the purpose of trafficking methamphetamine
- Possession of property obtained by crime

As a result of the arrest and search warrants, the following was located:

- 23.3 grams of Fentanyl,

equivalent to approximately 233 doses sold at street level (unless uncut – pure Fentanyl at 23.3 grams would be 23,300 doses)

- 26.8 grams of Methamphetamine, equivalent to 268 doses sold at street level

- \$4870.00 in Canadian Currency

• Stolen Honda generator
Tyson Niles was held for a bail hearing before being released. He is scheduled to appear on March 16, 2021 in Drayton Valley Provincial Court.

DEVON GENERAL HOSPITAL EXTENDS EMERGENCY DEPARTMENT HOURS

Phase 2 reopening expands patient access, from 8 a.m. to 10 p.m. daily

EDMONTON - Effective Mar. 15, the Devon General Hospital (DGH) emergency department (ED) will further extend service as part of its phased reopening, accepting patients from 8 a.m. to 10 p.m. daily.

The DGH ED reopened with limited phase one hours on Aug 18, 2020. It had been temporarily closed on April 20, 2020 as part of Alberta Health Services' COVID-19 response. The closure was implemented to

help protect long-term-care residents at the hospital, who are at heightened risk for severe illness if exposed to COVID-19.

To help protect these residents, a temporary barrier remains in place to allow ED patients to access services separate from inpatient areas of the hospital. As well, staff are designated to one area of the hospital and do not transition between the ED and inpatient units.

AHS will continue to monitor patient volumes and acuity regularly to determine when the hospital's

ED can resume 24-hour service. Until then, local residents seeking after-hours emergency care are advised to visit the Leduc Community Hospital or the Westview Health Centre in Stony Plain.

All patients requiring immediate medical care should phone 911.

Individuals requiring non-emergency medical care continue to be encouraged to call their family physician. To speak to a nurse and receive telephone advice and health information, families can also con-

tact Health Link 24/7 by dialing 811.

RURAL MUNICIPALITIES CONTINUE TO STRUGGLE AS UNPAID TAX AMOUNTS OWED BY OIL AND GAS COMPANIES INCREASE

The Rural Municipalities of Alberta (RMA) has conducted a member survey identifying that approximately \$245 million in property taxes currently owed to rural municipalities by oil and gas companies have gone unpaid. This continues the now multi-year trend of this issue worsening, as a similar survey conducted in early 2020 showed

unpaid amounts at an estimated \$173 million, and a 2019 survey estimated the amount at \$81 million. The latest survey shows a 42% increase in unpaid tax amounts compared to 2020, and a 203% increase from 2019. The \$245 million amount is based on a 100% response rate to the survey from all 69 RMA members.

Non-payment of property taxes by some oil and gas companies is an ongoing and increasingly urgent threat to the ability

of rural municipalities to provide the core infrastructure and services that the oil and gas industry relies on to access natural resources. RMA members manage over 70% of Alberta's roads and 60% of Alberta's bridges, and the revenue needed to manage this critical transportation network is almost entirely derived from property taxes. If municipalities are unable to depend on taxes being paid, they may be unable to manage roads and bridges at a

level required by the oil and gas and other industries.

"The fact that every rural municipality in the province took the time to complete this survey speaks to the anxiety and frustration that rural leaders are facing on this unpaid tax issue. In some municipalities, unpaid tax amounts are so high that service levels are being reduced, municipal staff are being laid off, and serious discussions are occurring about whether the municipalities can continue to function." - Paul McLaughlin, RMA President

While municipalities can take action to recover unpaid taxes on most residential and commercial properties, the oil and gas industry is subject to a legislative loophole that does not allow municipalities to place special liens or use other tax recovery tools on linear property. This puts rural municipalities in a powerless position to enforce the payment of property taxes on oil and gas companies and has made recovering unpaid taxes from both operational and non-operational companies extremely difficult. According to the member survey results, approximately 57% of unpaid taxes are the responsibilities of companies that continue to operate.

"As a homeowner, I am responsible for paying my property taxes or facing stiff penalties. Small business owners across the province are expected to pay property taxes regardless of the profitability of their business," McLaughlin said. "There is no reason why oil and gas companies should have an option to pay property taxes and face no consequences if they choose not to. Not only does this non-payment impact municipalities providing the infrastructure that those companies use every day, but it is also disrespectful to every other homeowner and small business in the municipality who will see their taxes increase or their service levels decrease due to the irresponsibility of some oil and gas companies."

Although this issue continues to become more serious, there are actions that could be taken by the Government of Alberta. The most straightforward provincial solution would be to amend the process through

Proposed Bylaw 2021-04: Mini Storage

Parkland County has seen increased regional demand for enclosed storage opportunities, such as self-storage for personal and household goods or storage for recreational vehicles, boats and personal vehicles. Currently, the County's Land Use Bylaw 2017-18 does not specifically address this type of use. To address this gap, Bylaw 2021-04 will add "Mini Storage" as a new use class and definition to the Land Use Bylaw and will outline new specific use regulations and fundamental use provisions to ensure land use compatibility.

Hearing Procedure

This is a formal Public Hearing and Council is prepared to hear and receive formal submissions and presentations (verbal or written) from those who wish to speak to the proposed Bylaw. Written submissions or presentations may either be submitted in advance to Planning & Development by 4:00 p.m. on March 31, 2021, or submitted at the commencement of the Public Hearing on April 13, 2021.

Anyone wishing to make a verbal presentation to Council must notify Planning & Development Services in advance of the Public Hearing by 4:00 p.m., on March 31, 2021. Verbal presentations at the Public Hearing will be limited to a maximum of 10 minutes. Please register at www.parklandcounty.com/participate to speak. Council advises that this is your last opportunity to comment on the proposed Bylaw as Council is unable to receive further submissions after the Public Hearing is closed.

Rural Municipalities Continue to Struggle as Unpaid Tax Amounts Owed by Oil and Gas Companies Increase

which the Alberta Energy Regulator approves the acquisition and transfer of energy licences and approvals. The current approval process uses a variety of financial criteria to determine whether an energy company has the fiscal capacity to take on additional licences. However, the process does not consider whether the acquiring company has outstanding municipal property taxes, a condition that could easily be added. The province could also amend the Municipal Government Act to clearly state that municipalities may use tax recovery powers available for other property types to address non-payment oil and gas property taxes. The province could also choose to no longer require municipalities to provide education property tax funds to the province on properties for which taxes are uncollectible. Under the current model, not only are municipalities not able to recover unpaid oil and gas property taxes, they are actually on the hook for forwarding a portion to the province, even if they are unable to collect it from the property owner. Unfortunately, the province has yet to take any action, despite repeatedly indicating that they take the issue seriously over the past several years.

McLauchlin said, "We appreciate that this is a complex issue, and that the province needs to thoroughly evaluate the options available. However, action is needed now. RMA and its members are willing to work with the province and the oil and gas industry to develop tools and incentives to lessen the property tax burden on industry during these difficult economic times. However, constructive dialogue will not take place while the oil and gas industry continues to take advantage of municipalities through the non-payment of property taxes, and the province stands by and does nothing. Let's have a conversation about how municipalities, industry, and the province can work together to support one another, rather than continue to let some companies take advantage of legislative loopholes."

It is important to note that while this is a province-wide issue, most oil and gas companies pay taxes on time, or work with the municipality to develop an agreement to defer taxes or pay

through installments. Many rural municipalities have recognized the issues facing the industry in recent years and have extended payment deadlines and reduced penalties for late payments. However, some companies still prefer to simply avoid paying property taxes, regardless of the impacts on the municipality and other property owners.

"Rural municipalities and the oil and gas industry have a long history of supporting one another to grow Alberta's econ-

omy and create vibrant rural communities," said McLauchlin. "Now that times are tough for the industry, that partnership is needed more than ever. We understand that those not paying taxes do not represent the entire industry, and most companies understand the important role municipal service and infrastructure play in the industry's success. We need to address this issue, ensure that oil and gas companies pay taxes the same as everyone else, and move forward

on how to build strong rural industries and communities."





STOCK UP ON VEHICLE BREAKDOWN SUPPLIES

Leaving a vehicle exposed to sunlight for extended periods of time increases the risk of damage to its interior and exterior. tures have been recorded well in excess of 145 F. Interior surfaces exposed to direct sunlight have been recorded at temperatures in excess of 195 F.

The automotive repair service Fix Auto says the sun's ultraviolet rays can cause the vehicle's paint to peel and fade over time. UV rays break down the molecules in the paint and make it appear dull. The company says red paint is particularly susceptible because red paint molecules deteriorate faster in the sun than other paint colors.

Avoid direct sunlight. Park in the shade as much as possible.

Crack a window. If it is safe to do so, lower interior air temperature and equalize air pressure by opening up car windows a little.

Use a protectant wax. A layer of wax can offer another layer of protection against the sun's ultraviolet rays.

Wash the car frequently. Washing and hand-drying the vehicle helps to remove dirt and other debris which can cause micro-scratches in the paint.

Install seat covers. Seat covers can protect leather and fabric upholstery. A leather conditioner can help prevent cracks and tears from sunlight and heat.

RELIEF FOR WORKING PARENTS

Submitted by Government of Alberta

Alberta parents who use child care will receive \$561 per child with the new Working Parents Benefit, a one-time payment to help parents with the cost of child care.

The Working Parents Benefit will see \$108 million go to families that used child care - including licensed

or unlicensed daycare, day homes, out-of-school care, or preschool - from April to December of 2020.

"Alberta's government is focused on protecting lives and livelihoods and that means being there for working parents. Families are facing additional stress due to the pandemic and the uncertainty in the economy. We want to directly support these parents by alleviating

the financial pressures they have faced this past year." - Rebecca Schulz, Minister of Children's Services

"It's great to see the government recognize the pressures that working parents are facing. As a single mother who has felt the stresses of work and child care this past year, this money is greatly appreciated." - Tiffany-Joy Robertson, working parent

The Working Parents Benefit adds to the recently announced Critical Worker Benefit, a \$1,200 payment to 330,000 front-line and essential workers, and the Enhanced COVID Business Benefit, a \$10,000 support for businesses hit hardest by the pandemic.

Families will be eligible to apply for the Working Parents Benefit if they have:

- Children in any form of child care, including licensed or unlicensed child care.
- A household annual income of \$100,000 or less.
- Paid for three months of child care between April 1 and Dec. 31, 2020 (must provide receipts).

A MyAlberta Digital ID is needed to apply for the benefit. Sign up for your MyAlberta Digital ID.

Apply for the Working Parents Benefit online at alberta.ca/WorkingParents-Benefit starting March 1. Applications close March 31.

Quick facts

- Families can apply starting March 1 to March 5, and applications will be open by region to manage volume.
- This \$108 million of unspent funds from Children's Services will be redirected under the Working Parents Benefit to support the families of up to 192,000 children.

- As of Feb. 12:
 - 96 per cent of daycares, preschools and out-of-school care programs (2,739 programs) are open.
 - Four per cent of programs (102 programs) are not open.
 - The 2,739 open programs have 115,285 spaces available. On average 58,003 children attended during the week, representing a 50 per cent enrolment rate.

- Child care operators have received more than \$100 million in COVID relief payments over the past year to address cost pressures and adhere to health, cleaning and safety guidelines.
