### PARKLAND RCMP ARREST SUSPECT FOR TRAFFICKING CONTROLLED SUBSTANCES

On April 8, 2021 at 3:15 a.m. Parkland RCMP responded to the report of suspicious vehicles parked on a rural private driveway in the area of Onoway.

Parkland RCMP identified

Jeffery Russell (37) of Drayton Valley, Alta. as a driver of one of the vehicles. A 34-year-old female from Seba Beach, Alta. was the driver of the other vehicle.

Initially during the investigation, the 34-yearold female provided a false name and was subsequently charged with obstructing justice. Her first appearance is scheduled for June 2, 2021 at Stony Plain Provincial Court. She cannot be named at this point in time as her court documents are still in the process of being sworn.

Gerald Soroka, Member of Parliament for Yellowhead, today questioned the government on Bill C-21 "An Act to amend certain Acts and to make certain consequential amendments (firearms)."

He asked: Mr. Speaker, the government's new gun confiscation bill is over-reaching. Not only will the legislation confiscate real firearms from law-abiding citizens, but it will also prohibit the sale of airsoft guns. One of my constituents owns a small sport-shooting store that sells airsoft rifles. His livelihood depends on business from the local airsoft club. Why is the government going after airsoft guns instead of criminals with illegal guns?

In Response: Hon. Bill Blair (Minister of Public Safety and Preparedness, Emergency Lib.): Mr. Speaker, as I have said, we have promised Canadians that we will strengthen gun control and we know that the Conservatives have promised the gun lobby they will weaken it. We are also listening, not just to those who profit from the sale of these firearms, but also to law enforcement who are tasked with the responsibility of keeping Canadians safe.

Jeffery Russell has prior charges involving weapons and is not to have weapons in his possession. He was found to be in possession of a weapon and was arrested for failing to comply with this condition. Further investigation found Jeffery Russell with a substantial amount of controlled substances and drug parapher-Investigators located nalia. approximately 10000 street doses of methamphetamine, fentanyl, cocaine and LSD.

Jeffery Russell is charged with:

• Possession for the purpose of trafficking - methamphetamine • Possession for the purpose of trafficking - crack cocaine

• Possession for the purpose of trafficking - fentanyl

• Possession for the purpose of trafficking - LSD

• Weapons possession contrary to order and fail to surrender authorization

Jeffery Russell was held for a judicial interim hearing and was released. His first appearance is April 28, 2021 at Stony Plain Provincial Court.

### New GTF Funding for Lac Ste. Anne-Parkland

Notable projects within Lac Ste. Anne County include rehabilitating bridges on Range Road's 24, 25, 40, and 62 and on Township Road's 583 and 590. Collectively these bridge upgrades received over \$500,000 in funding. Lac Ste. Anne County will also be replacing the bridge culverts on Range Road 55 and Township Road's 583 and 590, with the over \$400,000 they received from the GTF fund. Parkland County has received over \$9 million in funding for two major projects including the replacement of the bridge on range Road 64, and to upgrade and rehabilitate Parkland County Transfer Station and Recycling Center.

# SHOULD I DIY?: 3 QUESTIONS TO DETERMINE IF IT'S BEST TO RENOVATE ON YOUR OWN

pared to the cost of fixing DIY mistakes. Projects that are minor in scope and don't require the use of potentially costly specialty tools may be better suited for weekend warriors than more complicated renovations.

2. Do I have the time?
