AHS Postpones Some Non-Urgent Surgeries To Create Additional Hospital Capacity

This will result in the postponement of some non-urgent surgeries and procedures to ensure we have the beds and staff required to take care of all patients needing hospital care, including those with COVID-19 as well as other Albertans who are sick or injured.

This proactive approach mirrors similar surgical reductions during previous waves. AHS will maintain emergent, urgent procedures, as well as prioritized cancer surgeries.

These measures will help free up space in our hospitals for patients who need a higher level of care, and allow us to redeploy frontline staff and resources to areas of greatest need.

Any patient whose surgery or procedure is being postponed due to this temporary reduction will be contacted directly by AHS. To date, service adjustments are being planned in two zones.

In the North Zone, approximately 45 elective surgical procedures per week

Pursuant to Section 606 of the Municipal Government Act, the Council of the Town of Onoway gives notice that it has given First Reading to Bylaw No. 790-21 a Bylaw to amend Land Use Bylaw No. 712-13 to redistrict a portion of lands legally known as Plan 4114 TR; Block A from Residential – Single Family Narrow Lot District (RIN) to Urban Services District (US).

The Public Hearing for Bylaw No. 790-21 will be held on Tuesday, October 5th, 2021 at 7:00 p.m. at the Onoway Museum & Heritage Centre located at 4708 Lac Ste. Anne Trail North, Onoway, Alberta, as well there will be a virtual opportunity to participate.

Anyone affected by this proposed amendment may make a written or verbal submission. Your submission should contain your name and address; the location of your land; and your comments. Opportunity will be given to make both verbal and/or written submission at the time of the hearing. This public hearing is your opportunity to provide testimony & comment with respect to this proposed bylaw amendment, it is not a debate, it is not a question and answer session.

A copy of the notice along with proposed Bylaw 790-21 can be viewed on the Town's website, along with the virtual login information for this public hearing. www.onoway.ca at the Queen Elizabeth II Hospital in Grande Prairie will be postponed starting August 30. This will allow the site to increase bed capacity and create a dedicated COVID-19 unit.

In the Edmonton zone, up to 30 per cent of non-urgent surgeries and procedures will be postponed starting August 30.

AHS is currently working through the province's surgical backlog brought on by the pandemic. For the last two months we have been operating at 100 per cent of pre-COVID-19 surgical levels, and have been performing more non-urgent scheduled surgeries.

All backlogged surgeries in wave one have been rebooked and 96 per cent of all delayed surgeries from wave one, two and three have been completed.

We strongly urge all eligible Albertans to get immunized as quickly as possible, and to continue following preventative measures such as staying home when sick.

Alberta Health Services is the provincial health authority responsible for planning and delivering health supports and services for more than four million adults and children living in Alberta. Its mission is to provide a patient-focused, quality health system that is accessible and sustainable for all Albertans.



September 28, 2021 Community VOICE Page 7 ALBERTA RCMP MAJOR CRIMES UNIT INVESTIGATING DOUBLE HOMICIDE IN HINTON

On Sept. 16, 2021, at approximately 6 p.m., Hinton RCMP responded to a report of a missing 24-year-old female and her 16-month-old toddler who were last seen in Hinton.

Hinton RCMP, along with the assistance of Alberta RCMP Major Crimes, have been investigating this occurrence. The investigation is ongoing in the Hinton area and RCMP can now confirm that both the mother and her child have since been located deceased.

On Sept. 17, 2021, Alberta RCMP Major Crimes arrested a 53-year-old male in Hinton, in relation to this investigation. He remains in custody at this time.

Robert Keith Major (age 53) from Hinton, has been charged with two counts of 2nd degree murder and 1 count of indignity to human remains. He has been remanded into custody and is scheduled to make his first court appearance on Tuesday, September 21, 2021 at 10:00 am in Edson Provincial Court.

Investigators have learned that Robert Major lived in the same apartment complex as the 24-year-old female victim and her 16-month-old child. No other connection has been identified by between the victims and the perpetrator and police are not seeking any other suspects in this case.

Autopsies are taking place at the Edmonton Medical Examiners office today, September 18 and tomorrow, September 19, 2021.

This tragic loss of life is incredibly difficult for all involved, especially the family of the victims. The family has asked for privacy to grieve at this time and of respect for the wishes of the family, the names of the deceased will not be released by the RCMP.

Autopsies were completed at the Edmonton Office of the Chief Medical Examiner and the manner of death was deemed to be homicide in both autopsies.

Robert Major's next scheduled court appearance in Hinton Provincial Court is Oct. 20, 2021.

Due to inquiries from the public and the media, the Alberta RCMP would like to clarify that Robert Major had not been subject to any Recognizance conditions since July of 2020.

MP SOROKA EXPRESSES HIS GRIEF OVER THE TRAGIC LOSS OF MCHALE BUSCH AND NOAH MCCONNELL

As the Member of Parliament for Yellowhead, I am completely heartbroken over the heinous crimes that took place in our community of Hinton. I would like to extend my sincere condolences to the family and friends of Mchale Busch and Noah McConnell.

Knowing that a convicted sex offender had the freedom to commit two counts of second-degree murder and take two innocent lives is a complete failure of our justice system. This tragedy has highlighted the need for stricter laws surrounding the parole of sex offenders.

Cody Lee McConnell (spouse/father) started a petition on Change.org that will call on the government to: Amend the Criminal Code of Canada sentencing provisions for repeat sexual offenders by requiring mandatory minimum sentences for offenders with multiple sexual assault convictions who are designated to be at high risk to reoffend and lifelong parole.

Further, require registered offenders to update their personal information, including address and contact information every month or face jail time.

I strongly support this petition and encourage everyone to take the time to sign it. These are reasonable amendments to the Criminal Code, and I promise to take these much-needed changes to Parliament.

I will be consulting with the Parliamentary Law Clerk and our Conservative Shadow Ministers for Justice and Public Safety and with their support I plan on introducing a Private Member's Bill entitled 'Noah's Law'. I will work towards all party support so that the law is changed once and for all.

Until then, I hope the family and friends of Mchale, and Noah can take solace as our community rallies around them offering our comfort and support in this agonizing

times.





GOLF COURSES MANAGE PESTS TO PROTECT THEIR TURF

Golf courses are valuable green spaces in many communities, and the sport is enjoyed by Canadians of all ages.

We want our favourite course to be healthy, but this requires a lot of attention. Despite best efforts, sometimes golf courses are affected by pests. These can include turf diseases like dollar spot and snow mould, which affect normal growth of grass and can cause significant turf loss, according to experts. Turf insects feed on the grass and can inflict severe damage. Weeds are also a threat, because they compete with grass for moisture and affect the playability of a course.

To control pests, golf courses practice integrated pest management, using the right tool at the right time to treat an infestation. This includes pesticides, which are regulated by Health Canada to ensure they are safe and effective in controlling the pests they are designed to target. They help maintain healthy vegetation and playing surfaces, and also offer many environmental benefits.

Golf courses are often lo-

cated in urbanized areas and can be valuable green spaces that help preserve habitats for wildlife and waterfowl. Data show that healthy turf and trees act as natural air conditioners by producing large amounts of oxygen, while removing carbon dioxide. Did you know that healthy turf grass can sequester almost 900 kilograms of carbon per hectare each year?



ONOWAY LEGION COVID CLARIFICATION

At the last general meeting of the Onoway Legion, the decision was made to require double-vaccination for everyone participating in all Legion events.

As many businesses and organizations have discovered, with the continuing rise in active COVID cases, the choice is to put restrictions in place or close again. AHS guidelines make masks mandatory in all indoor public spaces and workplaces except when eating and drinking. This applies to Legion volunteer workers as well.

Some local people have questioned the need for the double-vaccination requirement so to clarify, here are the more frequent questions with answers.

1) What is the new vaccination requirement at the Onoway Legion?

You must be double-vaccinated against COVID-19 to enter the Onoway Legion Hall for all Legion activities, including meetings, sports events (darts, pool) and Friday night suppers.

2) When does this new requirement take effect?

It takes effect right away, but we will work with volunteers, members and patrons of the Legion to help people comply with the new requirement. We prefer education and encouragement as our primary tool.

3) Why is this being done now?

This is being done now because of the high rate of transmission of the Delta variant of COVID-19 as a way (combined with others such as physical distancing and mask wearing) to help protect our vulnerable volunteers, members and patrons, many of whom are in higher risk groups, so that we can keep our Legion open, safe and available to as many members and other patrons as possible.

4) What proof needs to be shown?

You need to show a written copy of your vaccination certificates. If you cannot locate the certificates that you were given upon vaccination, you can get another copy online through MyHealth Records (or use the MyHealth Records app) or by requesting another copy from the pharmacy or Doctor's office where you received your vaccine or by calling 811 if you got your vaccine at an AHS clinic.

5) What are the exceptions to this requirement?

There are three categories of persons who are exempt for this requirement, and efforts will be made to accommodate these persons.

(1) Persons who are unable to be vaccinated (a note from a physician needs to confirm that).

(2) Persons whose religious beliefs preclude the vaccination (a written note from a religious official such as a Minister explaining how vaccination interferes with the person's core religious beliefs must be provided). (3) Persons who are under 12 years of age.

6) How will information about my vaccination status be protected?

Persons will be required to show proof of vaccination upon entry. No copies of vaccination certificates will be taken or otherwise recorded or stored in any way. 7) Who will be enforc-

ing this? Legion volunteers will be enforcing this requirement as persons enter the Legion Hall. Please respect the fact that they are just doing their job.

8) Can I refuse to provide my vaccine status or proof of my vaccine status? Yes, you can refuse to provide your vaccine status and/or proof of that status. However, you will not be permitted to enter the Legion Hall and take part in Legion events if you choose not to provide the required proof of vaccination. We will be trying to assist with work-arounds, such as takeout meals for those who cannot enter.

9) What about private events that take place at the Legion?

Decisions about vaccination requirements, and enforcement, are the responsibility of the person or group responsible for the private event. Legion staff will be required to follow AHS requirements.

Lighting

Lighting is another factor remote workers must consider when they're planning their home offices. Natural light can provide an energetic boost and improve your mood, so choose a room in your home that gets lots of sunlight during the day. Many professionals who work remotely do so from the basements of their homes, which can make it difficult to rely on natural light. If the basement is the only location in your home that can fit a home office, look for lighting sources that replicate daylight so you are not working in dark quarters. Speak with your physician

about how to arrange lighting to reduce eyestrain caused by staring at a computer.

Connectivity

Factors To Consider When

Planning A Home Office

Connectivity also must be considered when planning a home office. While wireless Internet has made Internet dead zones less problematic, certain areas or rooms in your home may still be touch-and-go with regard to Internet connectivity. Such areas should be avoided when choosing a room for your home office, as it can be difficult to remain productive if your connection to your office's external server is routinely compromised. Find an area where the wireless connection is always strong. Distractions

While your home might be empty for much of the day, you don't want to be distracted when the kids come home from school or when your spouse or roommate arrives home from work. Avoid putting your home office too close to popular hangout areas in your home, such as the kitchen and the living room. Instead, choose a room where you have lots of privacy so you can focus on your work and won't be routinely interrupted.

Working from home can pay numerous dividends, but professionals who telework must put careful thought into the rooms or areas of their homes where they plan to work.





HOW TO PREVENT MOLD GROWTH IN YOUR HOME

Mold plays an important role in nature. Mold breaks down dead organic matter, including fallen leaves, and speeds up the decomposition process so nutrients can return to the soil as quickly as possible. But mold inside a home can be a formidable foe, triggering allergic reactions and increasing a person's risk of developing respiratory problems. Mold can even cause damage to a home by attaching itself to wood and breaking down that wood.

Because the consequences of mold growth inside a home can be so dire, it's important that men and women take steps to prevent mold growth in their homes and apartments. The U.S. Environmental Protection Agency notes that controlling moisture levels in a home or apartment is the key to controlling mold as well.

•Address spills quickly and properly. Many instances of mold infestations can be traced to leaks or spills that were not quickly or properly addressed. The EPA advises that wet or damp materials or areas should be dried within 24 to 48 hours to prevent the growth of mold. Make sure spills are

Inspect nearby crevices when spills occur to ensure the area where the spill happened and all surrounding areas vulnerable to mold growth are dry. In addition, fix leaky plumbing fixtures immediately, hiring a professional if necessary.

Inspect the ground surrounding your home.
 Factors outside a home can sometimes contribute to mold growth within a home. Make sure the ground outside your home slopes away from the foundation. If the ground slopes

toward your home, rainwater or runoff from sprinkler systems may direct water into your home, creating conditions favorable to mold growth inside. Gutters and downspouts also should be inspected to ensure they are working optimally. If not, they can contribute to water damage on the roof that can ultimately lead to mold growth.

•Monitor indoor humidity. The EPA advises that homeowners keep indoor humidity below 60 percent relative humidity, which can be measured with humidity meters available at many hardware stores. Homeowners who can keep indoor humidity at levels 30 to 50 percent below relative humidity might be even more successful at keeping indoor mold growth at bay.

•Dry wet surfaces immediately. Surfaces can become wet even if a home has no leaky fixtures and no spills have occurred. For example, the surfaces of bathroom walls, ceilings and floors get wet when a home's inhabitants take hot baths or showers. That condensation is natural, but such surfaces are also susceptible to mold growth. Make sure to dry wet surfaces immediately, and keep exhaust fans on or windows open when bathing to decrease the likelihood of mold growth.

Mold growth can be detrimental to human beings and their homes. But many mold infestations are easily prevented.

ALBERTA RCMP LAUNCHES ONLINE CRIMINAL RECORD CHECKS IN SELECT DETACHMENTS ACROSS THE PROVINCE

In an effort to provide simpler, more efficient public service, a pilot of an online criminal record check tool begins Sept. 22, 2021 in select Alberta RCMP detachments. Criminal record check information typically obtained from RCMP detachments can now be accessed online. If this online service option is successful, it will be expanded to other locations.

A criminal record check is obtained to determine if a person has been charged or convicted of a crime. Vulnerable sector checks (VSC) are included in the service provision for criminal record checks. A VSC is a police information check which is done to protect children and other vulnerable people from physical, sexual, mental, and financial abuse. A VSC is the most thorough of all background checks available.

To Vote Lac. Ste. Anne County

D. In order to vote, you must produce identification for inspection. The identification must be one or more of the following as required by section 53 of the Local Authorities Election Act.

Any of the following documents that has the voter's name and address on it will be accepted as valid proof:

- Identification issued by a Canadian government, whether federal, provincial or local, or an agency of that government, that contains a photograph of the elector and their name and current address.
- · Bank or credit card statement or personal cheque.
- · Government cheque or cheque stub.
- · Income or property tax assessment notice.
- · Insurance policy or coverage card.
- · Letter from a public curator, public guardian or public trustee.
- · Pension plan statement of benefits, contributions or participation.
- Residential lease or mortgage statement.
- Statement of government benefits (for example, employment insurance, old-age security, social assistance, disability support or child tax benefit).
- · Utility bill (for example, telephone, public utilities commission, television, hydro, gas or water).
- · Vehicle ownership, registration or insurance certificate.

A letter or form (attestation) confirming that the person lives at the stated address will also be accepted as valid proof. The letter can be signed prior to the vote by any of the following:

- authorized representative of a commercial property management company;
- authorized representative of a correctional institution;
- authorized representative of a First Nations band or reserve;
- · authorized representative of a postsecondary institution;
- · authorized representative of a facility that provides services to the homeless; or
- · authorized representative of a supportive living facility or treatment centre.

If a voter's identification shows a post office box number as the address instead of a residential or legal address, it can be accepted as verification of current address if it is in reasonable distance to the voting jurisdiction. The address does not have to be in the voting division or ward.

An elected authority could, by bylaw, require additional verification or a combination of verification to establish the person's specific current address.

As required by section 53 of the *Local Authorities Election Act.* DATED at Lac Ste. Anne County, in the Province of Alberta, this 20th day of September, 2021.

Online criminal record checks will be processed within the same timeframe as they are typically done in person and will be mailed to the applicant, unless arrangements have been made for collection at the detachment. The timing of this tool is important and beneficial, as physical distancing measures have encouraged people to minimize gathering and proximity with others.

The pilot program is currently only available to the following detachments: Bashaw, Cochrane, Consort, Drayton Valley, Drumheller, Grande Prairie, Provost, St. Albert, St. Paul, Sundre, and Sylvan Lake. Criminal record checks will continue to be available in person at all detachment locations and will be the only option for any location area not covered for the pilot program.
