Alberta's natural gas rebate program continues to offer price protection for Albertans from volatile natural gas prices. As December's highest monthly default natural gas rate will be \$6.167 per gigajoule, the rebate will not be triggered. How the rebate works

To support natural gas consumers this winter, the natural gas rebate program is ready and in place to protect Albertans. The exact rebate amount that consumers will receive depends on the default natural gas rate each month.

Should the monthly default natural gas rate from any of the regulated utility providers (ATCO Gas North and ATCO Gas South,

as served by Direct Energy Regulated Services or Apex Utilities) exceed \$6.50 per gigajoule, the government will provide rebates to all eligible consumers covering the difference. For example, if the highest regulated rate is \$7.50, eligible consumers would get a rebate of \$1 for every gigajoule used in that month. More than 1.6 million Albertans are eligible for a rebate, including consumers connected to the natural gas distribution system and those not connected to the natural gas distribution system but using natural gas, propane, kerosene or heating oil for heating purposes. SUPPORTING FOOD SECURITY FOR ALBERTANS

FEDERAL GOVERNMENT ANNOUNCES FUNDING FOR NEW EV CHARGERS IN LEDUC, ALBERTA

Reducing pollution from the transportation sector is critical to Canada achieving its climate targets. That's why the Government of Canada is making it more affordable for Canadians to purchase, charge and drive electric vehicles (EVs) in Alberta and across the country.

Today, the Honourable Randy Boissonnault, Minister of Tourism, Associate Minister of Finance and Member of Parliament for Edmonton Centre, on behalf of the Honourable Jonathan Wilkinson, Minister of Natural Resources, announced an investment of more than \$69,000 in the City of Leduc to install four EV chargers in public places. Funded through Natural Resources Canada's Zero-Emission Vehicle Infrastructure Program (ZEVIP), all chargers are now available for use. The City of Leduc also contributed more than \$69,000, bringing the total project cost to more than \$138,000.

Since 2016, the Government of Canada has invested a historic \$1 billion to make EVs more affordable and chargers more accessible for Canadians. These investments are supporting the establishment of a coast-to-coast network of chargers in local areas where Canadians live, work and play, while federal rebates of up to \$5,000 are helping more Canadians make the switch to an EV.

Budget 2022 delivered an additional \$1.7 billion to extend the incentive program until March 2025 and to expand the types of vehicle models eligible under the program, which would include more vans, trucks and SUVs. Canada is advancing toward the deployment of 50,000 new chargers supported by \$400 million in investments and \$500 million in financing through the Canada Infrastructure Bank.

The 2022 Fall Economic Statement includes a refundable investment tax credit for clean technologies including industrial zero-emission vehicle charging and refueling equipment, alongside support for clean energy generation and storage. The statement also included the creation of a Sustainable Jobs Training Centre and Secretariat, which will support thousands of workers in skills training and placements in the low-carbon economy.

These investments are yet another step in reaching Canada's target of ensuring all new passenger vehicles sold in Canada are zero-emission by 2035. And just like investments in everything from clean technology to nature protection, today's announcement is part of achieving Canada's ambitious climate change goals to build a cleaner, healthier and affordable future for all Canadians.

Premier Danielle Smith has wasted no time getting to work on reforming Alberta's healthcare system.

This past week, Premier Smith joined Health Minister Jason Copping to announce that Dr. John Cowell has replaced AHS' part-time board of directors as its full-time administrator on a six-month contract. Dr. Cowell has extensive knowledge of and experience in Alberta's healthcare system and will bring strong, decisive leadership to his new role.

Dr. Cowell will work directly with Mauro Chies, the interim AHS CEO, to address four important goals: improve EMS response times, decrease emergency room wait times, reduce wait times for surgeries, and develop long-term reforms through consultations with front-line workers, including discovering ways to restore decision-making to local healthcare professionals and authorities.

We know Alberta has the best frontline healthcare staff in the entire world, but despite the excellent work of our doctors, nurses, paramedics and other frontline staff, our patients are waiting too long to access the care they deserve. As Premier Danielle Smith said, "we need more-urgent action to improve access. Albertans want accountability within AHS, and they want to know that a world-class health system and level of care is available when they need it."

Help is now here. We all wish Dr. Cowell success as he begins working to improve emergency response times and reduce wait times for patients and their families. Albertans care deeply about their healthcare system. They want and need it to work right, so it's there to support them and their loved ones, should they need it. Dr. Cowell will deliver the change we need.

Ultimately, Albertans will know whether these changes are working to improve the system, because we will measure the outcomes through transparent performance measures. Although there are many unknowns in healthcare, Dr. Cowell has said he is confident that there will be measurable improvement by next year in how the healthcare system is operating.

68,400 Albertans are currently waiting for surgeries that will improve their health and quality of life. That number is down from the 81,000 Albertans who were waiting at the height of the pandemic, but it is still too high. Getting surgical wait times down is a key area of focus for Dr. Cowell, and an area I and so many others look forward to seeing improvement.

We must be honest about the state of our healthcare system if we're going to fix it. Right now, the system is struggling to keep up with growing demand. The driving force behind these changes is building a system that is not only strong but resilient to changing circumstances and growth pressures.

Like you, I cherish the work of our frontline healthcare workers and I care deeply about the system they operate in. That is why I am pleased to see our government acting to resolve these longstanding issues in our healthcare system.

We will not kick the can down the road. We will act now to ensure Albertans have the worldclass system they deserve for generations to come.

New facility continues to promote Leduc's efforts to reduce carbon emissions

The City of Leduc announced today its new solar carport and four electric vehicle (EV) charging stations, located at ATB Financial, 4821 50th Ave., are now fully operational and open to the public. Both projects represent a total cost of \$217,000.

The projects were funded by the City of Leduc in partnership with Natural Resources Canada (NR-Can) and the Municipal Climate Change Action Centre, as we continue our commitment to reducing our carbon footprint and finding green energy alternatives.

Through its Zero Emission Vehicle Infrastructure Program (ZEVIP), Natural Resources Canada (NR-Can) invested more than \$69,000, representing 50 per cent of the costs associated with the electric vehicle charging stations, with the City of Leduc funding the remaining 50 per cent.

Through the federal government's Budget 2022, Canada is advancing the deployment of 50,000 new chargers supported by \$400 million in ZEVIP investments and \$500 million in financing through the Canada Infrastructure Bank. This is in addition to the more than 34,500 already selected for funding through NRCan.

The Municipal Climate Change Action Centre (MCCAC) is a partnership of Alberta Municipalities, Rural Municipalities of Alberta and the Government of Alberta. Since 2009, the MCCAC has supported Alberta's municipalities in installing 29.6 MW of solar electricity generation capacity across the province, saving taxpayers \$7.7 million annually. The City of Leduc solar carport's solar modules were installed with financial support from the MCCAC's Alberta Municipal Solar Program as part of a grant that covered 21 per cent of the solar carport costs, with the City of Leduc funding the remaining 79 per cent.

The City of Leduc's solar carport has the capacity to generate 20,000 kWh of clean electricity a year for the four electric vehicle chargers. This solar-generated electricity feeds into the grid where it will be immediately available to EV drivers using the solar carport's newly installed level 2 and level 3 chargers. This arrangement makes the solar carport one of the first of its kind in Canada. The carport's 823 solar PV modules will reduce greenhouse gas emissions by 285 tonnes over 25 years.

"The opening of the solar carport and electric vehicle charging station provides Leduc residents and visitors another incentive to visit, shop, and work in downtown Leduc, while continuing to support our local economy," said City of Leduc Mayor Bob Young. "This facility was built with the support from the federal and provincial governments, and it strengthens our commitment to finding ways to reduce our carbon footprint and using green energy wherever possible."

"We're making electric vehicles more affordable and charging more accessible where Canadians live, work and play," said the Honourable Jonathan Wilkinson, Minister of Natural Resources Canada. "Investing in more EV chargers, like the ones announced today in Alberta, will put more Canadians in the driver's seat on the road to a net-zero future and help achieve our climate goals."

"Our government is making milestone investments in electric vehicle manufacturing and related infrastructure that our province needs," said the Honourable Randy Boissonnault, Minister of Tourism, Associate Minister of Finance and Member of Parliament for Edmonton Centre. "Today's announcement of four electric vehicle chargers in the City of Leduc will not only help current residents' transportation needs, but provide infrastructure for our future. Thank you to everyone that came together to make this possible. Let's keep working together to build a greener world for the next generation of Albertans and all Canadians."

"Sunlight feeding into solar panels becomes one of the cheapest vehicle fuels available. I commend the City of Leduc's innovative spirit in building one of Canada's first electric vehicle charging solar carports," said Trina Innes, Executive Director of Sustainability Services, Alberta Municipalities.

• If you are expecting personal identification such as a renewed driver's license or other government-issued identification, contact the issuing agency immediately.

If you are expecting

to receive utility bills, contact the appropriate companies to ensure that you don't accidentally miss payment. Stolen bills can also be used by fraudsters in attempts to steal your identity, open new accounts or get cash loans.
